Could it be that M'Neill did not mention murder as Arrell would have telegraphed before going to the scene, he wanted Connolley to wire (sent about 12:15) Dan Jnr so he could be first to Gatton to assist the family.

According to Arrell's times M'Neill left about 10:05 and got home about 10:20.

M'Neill realises he has made a mistake and if anyone was smart enough to look closely at his stated doings they would realise he should have arrived in Gatton at about 10:00 and he would be caught out as a liar as he made a mistake and came into Gatton too quickly arriving at (as stated by Arrell) 9:15.

This means he has 45 minutes unaccounted for to do what he said he had done he tries to cover up by continually saying from then on, that he arrived in Gatton at 10:00 pm and got back to the Murphy's farm at 11:00 am when the rest of the family state that he arrived just after 10:00 I surmise about 10:15-10:20 enough time to relate the tale and get back to the scene by 11:45.

These times are borne out by Ballantyne's evidence as he states that M'Neill and Mrs Murphy were at the scene when he arrived which would have been between 11:20 and 11:30.

The rest of the family state he was back about 10:00.

Realising his mistake he later says he arrived home at about 11:00.

Plus Devitt and Wilson both state that only 2 other people arrived before M'Neill and Mrs Murphy which means they got there pronto as when Arrell returns there are at least 20 people at the scene.
